**1038. Adv H C Schmidt (DA) to ask the Minister of Water and Environmental Affairs:**

- (1) In light of her reply to question 400 on 10 March 2010, what steps is her department taking against mining companies who do not comply with the provisions of the National Environmental Management Amendment Act, Act 62 of 2008, with regard to decanting water from the (a) Wesselton Mine (b) Coastal Fuels mines, (c) Sumo Colliery and (d) Umlaba Colliery (details furnished);
- (2) Whether the Eerstelingsfontein mine is decanting water; if not, what is the position in this regard; if so, what are the relevant details;
- (3) What steps are being taken to ensure that the mines are prevented from decanting water into the natural water systems and rivers? NW1184E

**REPLY:**

- (1) The four mines were either in operations and/or closed prior the promulgation of the National Water Act, 1998 (Act No. 36 of 1998) (NWA). For such mines, the provision for regulating of decanting after closure was set as condition(s) in the erstwhile Department of Mineral and Energy Affairs' Environmental Management Project Reports (EMPRs), as the previous Water Act, 1956 (Act No 54 of 1956) did not address decanting as a water use.

Please note that the National Environmental Management Amendment Act, Act 62 of 2008 ("NEMA") does provide for environmental issues resulting from mining, prospecting, production and related activities to be regulated in terms of NEMA in the future. Although the NEMA came into effect on 1 May 2009 there is still an amendment to the Mineral and Petroleum Resources Development Act ("MPRDA") that needs to come into effect in order for the provisions of the NEMA to commence. It is unclear when the amendment to the MPRDA will come into effect.

- (2) No, in accordance with my Department's site inspection carried out on 26 January 2010, the Eerstelingsfontein mine was not decanting water.
- (3) The Rehabilitation and Closure Strategy to be submitted by a mining company as stipulated for the Closure Phase of the specific mine, makes provision for the prevention of future decanting and/or the management thereof. My Department uses Section 19 of the NWA to control and/or prevent pollution of water resources. If there is a potential for decanting by a mine, my Department can issue a Section 19(3) notice to the mine for it to take the necessary measures that will prevent pollution. My Department conducts monthly water quality monitoring of the water resources to ascertain compliance.
