MINISTER OF WATER AND SANITATION

A total of 125 enforcement actions were taken by the Department of Water and Sanitation (DWS) against non-compliant water users and polluters in the 2024/25 financial year.

Enforcement actions taken are indicated below:

- (i) 79 Notices of Intention to Issue Directives (see **Table 1** below for details)
- (ii) 32 Directives (details provided in **Table 2** below)

(iii) (aa) 14 criminal cases for non-compliance with the National Water Act, 1998 (see Table 3 below for case details) during that period. This represents 111 administrative actions (notices and directives) 14 cases are under criminal investigation.

(bb) The outcomes of enforcement actions were as follows:

- DWS received 28 representations which were assessed
- 11 cases being resolved through the implementation of rectification measures.
- 9 action plans are being monitored for the implementation
- 3 corrective action plans did not meet the requirements and were referred back rejected and further enforcement actions (Directives) were issued
- There are 5 representations that are currently under assessment to determine compliance with regulations

The department is monitoring a total of 86 cases that are under administrative action to ensure compliance with legislative requirements. Failure to comply will result in further enforcement action which maybe civil or criminal action or both.

Regarding the criminal cases, all 14 are under investigation. When the process to collect evidence and samples is completed, the case dockets will be referred to the National Prosecuting Authority (NPA) for a decision on prosecution.
