INVITATION TO SUBMIT WRITTEN COMMENTS ON PROPOSED GENERAL AUTHORISATION IN TERMS OF SECTION 39 OF THE NATIONAL WATER ACT, 1998 (ACT NO 36 OF 1998)

The Director-General of Water Affairs and Forestry intends to generally authorise the using of water for recreational purposes in terms of section 39 of the National Water Act, 1998 read together with section 21(k) and subject to the terms and conditions contained in Schedule 1 hereto.

In terms of section 39(4)(a)(ii) interested parties are invited to submit written comments in connection with the proposed general authorisation by **31 August 2001**. SCHEDULE

USING WATER FOR RECREATIONAL PURPOSES
[Section 21(k)]

Purpose of this authorisation

1. The water use authorised in terms of this Notice replaces the need for a water user to apply for a licence for recreational purposes in terms of the National Water Act, provided that the water use is within the limits and conditions set out below.

Compliance with National Water Act and other laws

2. This authorisation does not-
 - (a) replace or limit any existing authorisation that is recognised under the Act; and
 - (b) exempt a person undertaking recreational water use from compliance with any provision of the Act unless stated otherwise, or any other applicable law, regulation, ordinance or by-law.

Area of applicability

3. This authorisation is applicable throughout the Republic of South Africa but excludes recreational water use within protected areas.

Duration of authorisation

4. This authorisation will be valid for a period of three years from the date of publication of this Notice, unless-
 - (a) it is amended at any review period, which period shall be at intervals of one year from the date of publication of this Notice;
 - (b) the period is extended by a further notice in the *Gazette*; or
 - (c) the water user is required to apply for a licence in terms of the Act.

Definitions

5. In this Notice, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Act, shall have that meaning, and-
 - (a) **"protected areas"** refers to those areas included in the Department of Environmental Affairs and Tourism's *National Register of Protected Areas in South Africa* contained in Table 1 below, as amended from time to time.
 - (b) **"commercial recreational water use"** refers to recreational use of water for financial gain, including organised sporting activities and events.
 - (c) **"high impact recreational water use"** refers to the recreational use of water where-
 - (i) vessels may travel at a speed exceeding 50km/h;
 - (ii) the number of bank anglers exceed the carrying capacity limit of 10 meters of shore line per bank angler; or
 - (iii) the number of vessels exceed the carrying capacity limits as set out here under.

RECREATIONAL USE	CARRYING CAPACITY LIMITS
Boat angling	3 hectares water surface per boat where there is the requirement to move around, otherwise 1 hectare per boat
Sailing	6 hectares water surface per sailing boat
Leisure canoeing, rowing or similar activities	0.5 hectares water surface per vessel
Motorboats, jet skiing or similar activities	6 hectares water surface per boat
Recreational water skiing or similar activities	16 hectares water surface per boat

- (d) **"management plan"** refers to the plan, for the management of and control over the water surface and water body of a government waterworks and the surrounding state-owned land, approved by the Minister of Water Affairs and Forestry.
- (e) **"the Act"** means the National Water Act, No. 36 of 1998.
- (f) **"the Department"** means the Department of Water Affairs and Forestry.
- (g) **"recreational water use"** refers to water related activities including swimming, angling, sailing, canoeing, rowing, boating, jet- and water skiing, undertaken for the exclusive purpose of recreation or leisure.
- (h) **"vessel"** refers to any craft capable of navigation by water.

Access to a water resource for recreational use of water

6. A person who has lawful access to a water resource may use the water surface or body of that water resource in terms of this Notice for recreational use if the use -
- (a) does not detrimentally impact any other water use;
 - (b) is not harmful or potentially harmful to human health, or to the water resource;
 - (c) is not for commercial recreational water use;
 - (d) is not high impact recreational water use;
 - (e) does not involve use of vessels for overnight accommodation purposes; and
 - (f) is not limited or prohibited in terms of an approved management plan for a water resource.

Precautionary practices

7. The recreational user must take adequate measures to ensure-
- (a) that the owner or skipper of a vessel at all times-
 - (i) operates or handles the vessel responsibly and carefully;
 - (ii) is physically able and of sound mental health;
 - (iii) is not under the influence of intoxicating liquor or any substance having a narcotic effect;
 - (iv) ensures that the vessel when not in use, shall be securely anchored or moored so as not to endanger other vessels or persons on the water or along the shore;
 - (v) ensures that the number of persons aboard a vessel does not make the vessel unsafe; and
 - (vi) has the standard of knowledge and experience for navigating or otherwise operating or handling the vessel. No person under the age of sixteen years may pilot or be in charge of any engine-powered vessel;
 - (b) all vessels are constructed of suitable materials of good quality with regard to sound design practise and methods of construction;
 - (c) safety equipment adequate for the safety of the maximum number of persons, in particular flotation aids and lifejackets, is provided and maintained to industry standard and used in the best interest of the occupants;
 - (d) relevant safety rules and lawful notices, warnings, water traffic signs and signals are obeyed;
 - (e) individual noise levels of vessels do not exceed 75 decibels (dB) at 25 meters and the activity noise will not be more than 10dB above ambient noise;
 - (f) that the stability of the watercourse and the water quality is not detrimentally affected;
 - (g) scouring, erosion or sedimentation of the watercourse is prevented;
 - (h) indigenous riparian vegetation is not removed or damaged;
 - (i) the habitat of aquatic biota is not interfered with; and
 - (j) that waste is not disposed into a watercourse or on the surrounding land, except at such places provided for the purpose.
8. In the case of State dams-
- (1) for which an approved management plan does not exist-
 - (a) no recreational facilities or structures may be established on land over which the State has rights without authorisation by the Department;
 - (b) no recreational activities may take place within a minimum distance of 100m from the dam wall and outlet works or spillway;
 - (c) no activities may take place, where cruising speed and high wake disturbances are involved, within 70 meters from the water's edge and in the river inlet areas to the dam,
 - (2) where there is an approved management plan for a water resource, activities must take place in accordance with such a plan.

Record keeping and disclosure of information

- 9.(1) The recreational user may be requested to keep records of aspects related to the water use and make the information available to the responsible authority.
- (2) Any information on the occurrence of any incident that causes, or may cause, detrimental impacts on the water resource quality must be provided to the responsible authority in terms of section 20 of the Act.

Registration

10. A person who uses water in terms of this Notice need not register the water use as contemplated in Regulations R.1352 published in Government Gazette 20606 dated 12 November 1999.

Inspections

11. Any property or land in respect of which a recreational water use is authorised in terms of this Notice must be made available for inspection by an authorised person in terms of section 125 of the Act.

Offence

12. Any person who contravenes any provision of this Notice is guilty of an offence and is subject to the penalty set out in section 151(2) of the Act.
