It was clarified during the briefing session that C 2.1 was a typo, it should be 4ME not 5CE.

Also the minimum threshold should be 4CE and not 5ME as per bid document. This error will be corrected in addendum.

Only contractors meeting the minimum criteria per category of CIDB Grading will be allowed to move to Phase 5.

An emphasis was made to bidders to pay attention to annexure 3 (**participation of local enterprises**) to ensure that the community benefits from this tender. It is the responsibility of the bidder to find suitable subcontractors in Emfuleni Local Municipality, in case where no suitable subcontractor in Emfuleni Municipality the contractor may be selected from the two municipalities of Sedibeng District namely Midvaal and Lesedi LM's. In the case where there are no suitable subcontractors in Emfuleni Local Municipality and two municipalities of Sedibeng District, subcontractors shall be selected from within the Gauteng Province

In total 60 %?	<p>This will be applicable to contract participation goal where it is stipulated in this contract as condition whereby the bidder will have to identify and subcontract minimum of 30% of work to the companies from priority population group owned.
