PROCEDURE FOR ADDENDA

TABLE OF CONTENTS

1. AMMENDMENTS REQUIRED TO TENDER DOCUMENTS

Amendment No 1 – Changes to the closing date of the tender, number of documents to be submitted and compulsory sub-contractor documents.

- (i) Potential contractors/ bidders are requested to take note of the new closing date of the tender. This tender will now close on **13 August 2021** and not **05 August 2021** as previously advertised.


Bids received later than 11:00am on **13 August 2021** will not be considered and will be returned unopened to the sender.

- (ii) Potential contractors/ bidders are requested to submit one original bid document and two copies of the bid document as requested at the compulsory briefing session.

- (iii) The proposed **30% Compulsory Subcontractors (Designated groups contractors) must also have the following documents before signing the contract with the department:**

- ✓ A valid letter of Good Standing with the Compensation Commissioner in terms of the Compensation for Occupational Injuries and Diseases Act No 130 of 1993 and or third parties insurance registered with Financial Service Board. (Verification will be done with the relevant authority).
- ✓ A copy of a valid UIF certificate of compliance or copy of a valid letter of good standing/ tender letter. (Verification will be done with the Department of Labour).

A bidder will not be disqualified if it fails to submit the above mentioned two documents of their proposed subcontractors on the closing date of the bid, however no contract will be signed with a contractor who's sub-contractor doesn't have the required proof of UIF and COIDA.








