- **Question 4:** We see that the certificates mentioned above need to be authorized. Please confirm that authorisation is required considering Covid regulations.
- N.B: Answer: If it is a requirement for all the certificates to be certified, please make sure that you certify or your bid will be disqualified. Please ensure that you comply with all requirements.
