<p>I previously joined a bid by another PSP as a subconsultant to them. The company wants to submit their own bid with me on their bid. Will it be acceptable that my CV appears on 2 bids?</p>	<p><b>A single CV may not be included in two separate bid submissions for the same tender. The use of the same personnel across multiple bids may be regarded as bid collusion or a conflict of interest. Please refer to point 3.3 and 3.4 of the bidder's disclosure form. Suppliers must ensure that personnel are not placed in situations that may result in an unfair competitive advantage. Assigning the same expert to two separate bidders creates a conflict of interest, as the individual would not be able to realistically fulfil obligations for both parties should both bids be successful ( if a panel was to be appointed)</b></p>
<p>Kindly confirm whether this tender requires submission under a two-envelope system (separate technical and financial proposals) or if a single combined submission will suffice.</p>	<p><b>Please note that proposals should be submitted via the website / Online through E-Tenders E-submission Portal, as we no longer accept hard copies. Proposal and Pricing schedule must be on the same document not separated.</b></p>
<p>Kindly clarify Item 6 under the <i>Administrative Compliance</i> criteria:</p> <ul style="list-style-type: none"> <li>• What specific document(s) are required to be submitted; and</li> </ul>	<p><b>Document required (JV/Consortium ), Consolidated B-BBEE certificate for Joint ventures, Full CSD report. Bidders submitting a Joint Venture proposal must include a formal Agreement between the participating firms. The agreement must clearly specify the percentage involvement of each firm within the joint venture.</b></p>
