

(2) Yes, My Department provides comments on all mining applications from Department of Mineral Resources in terms of the Environmental Management Plan (EMP) and ensures that the mines compile the Integrated Waste Water Management Plan (IWWMP) before commencement with the mining operations.

Furthermore, the Department of Mineral Resources will only issue the Authorization to mines subject to the mine issued with the Water Use License. My Department and the Department of Mineral Resources have agreed that the Water Use Authorization Process will run parallel with the mining right application process in order to ensure that mining do not commence without a Water Use License.
