219 Mrs D R Tsotetsi (ANC) to ask Minister of Water and Environmental Affairs:

(a) What budgetary allocations have been made towards water quality and safety in the 2010-11 financial year at a national and regional level, (b) how much budget was spend in the specified year, (c) what are some of the challenges that have been faced by her department in its implementation of the specified budgetary allocation, (d) how is the national budgetary allocation divided and allocated to regional offices and (e) how was this money spent?

REPLY:

My Department allocated the following budget towards water quality and safety in the 2010 - 2011 financial year:

(b)

- R 417 209 802 was spent on regions
- R1,148,195.24 was spent on Blue Drop
- R3,092,535.55 was spent on Green Drop

(c)

- Long procurement and design process of projects.
- Contract administration problems in municipalities.
- Legal action taken (tenders, designs).
- Reluctance of farmers to allow groundwater development.
- Non performing contractors and cash flow problems.
- Limited institutional capacity to manage project.
- Delays caused by suppliers (strikes).
- Completed IRS may take **long time** before they are implemented, long delays also caused by **EIA (RoD) and** approval of **water use licenses**, lack of power supply **Eskom**.
- WSA reluctant to continue / commit due to partial funding or tenders are much higher than estimates.
- Consultants appointed for feasibility studies by WSA are often found to be lacking in ability to execute.

(d)

- Provincial Master Plans have been compiled determining the total bulk water need per municipality.
- The Department use the determined need combined with the water and sanitation backlog and calculate the percentage budget allocation for each province.
- The budget allocation as indicated above per project has been spent through approved procurement procedures.

(e)

- The budget allocation was spent on water infrastructure e.g. concrete reservoirs, water treatment works, pump stations, steel and PVC pipes.
- National Blue and Green Drop Reports were compiled, printed and released by the Minister at the Water Quality Conference.
- The budget allocation was also spent on purchasing the uniform for the Blue and Green Drop Inspectors.
- The budget allocation as indicated above on Blue and Green Drop has been spent through approved procurement procedures via the Implementing agent.
