3313. Ms B D Ferguson (Cope) to ask the Minister of Water and Environmental Affairs:

(1) Whether she has been informed that in areas like Nkandla, KwaZulu-Natal, (a) 62% of households do not have access to clean water; if not, what is the position in this regard; if so, what are the relevant details?

REPLY:

(1) The Uthungulu District Municipality (Uthungulu DM) is the Water Services Authority for the Nkandla Local Municipality (Nkandla LM) and is responsible for the provision of water services. The Uthungulu DM's Integrated Development Plan (IDP) confirms the water supply backlog in the Nkandla LM as 32% and not 62%. Of the 25 757 households in the Nkandla LM, 8 131 households do not have access to formal water supply. The Uthungulu DM, comprising of five local municipalities has a total water supply backlog of 41%, with the Nkandla LM having the second lowest backlog.

In order to address the water supply backlog, the Uthungulu DM is currently implementing several water projects and has further planned for projects to be implemented over the next 3-years. These projects are shown in table 1 and table 2 respectively. Communities without formal water supply or reliable water source, are being supplied with water through the Nkandla Tanker Reduction programme.
