# DATE OF PUBLICATION IN INTERNAL QUESTION PAPER: 04 JULY 2014 (INTERNAL QUESTION PAPER NO. 1)

# 4. Ms T G Mpambo-Sibhukwana (DA-WC) to ask the Minister of Water and Sanitation:

- (a) Which municipalities in each province have overdue accounts with (i) Water Services Authorities, (ii) other municipalities and (iii) any other water service providers and (b) what amount in each case;
- (2) (a) what is the outstanding amount in each case as at 31 May 2014, (b) what terms of payment have been negotiated with each municipality and (c) which municipalities are continuous offenders that renegated on previous payment arrangements;
- (3) whether she has a recovery plan to collect funds from indebted municipalities; if not, why not; if so, what will be the (a) monthly payments against debt ratio and (b) period of redemption;
- (4) whether the outstanding debt will have any negative effects on the provision of water in each municipality; if not, what is the position in this regard; if so, what are the relevant details;
- (5) whether the outstanding debt had any influence on (a) service delivery and (b) health issues; if not, what is the position in this regard; if so, what are the relevant details?

(1)(2) Refer to table below for the summary of overdue accounts on the outstanding amounts in each case as at 31 May 2014 owed by Municipalities to Water Boards, as Water Services Authorities and Water Services Providers.

(3) A task team was formed with representatives from the Department; National Treasury and the Department of Corporate Governance to intervene in dealing with the issues of debt recovery. However, a recovery plan will further be discussed with the recently established Service Delivery Committee.

- Yes, the outstanding debt has serious negative effects on the provision of water services to the municipalities. The Water Boards as Water Services Providers have obligations to honour their monthly payments to the stakeholders or institutions that supply them with resources to make the organisations fully operational, e.g., ESKOM, chemicals, the Department of Water and Sanitation on raw water accounts, the staff, etc, in running of the daily business of the organization.
- (5) Even though the debt impact assessment has not been done yet with respect to service delivery and health issues, there is likelihood that these could be affected depending on the financial viability of the respective water services authority or provider.
