- (2) (a) What will be the cost of rehabilitating the water and sanitation infrastructure in the specified municipality and (b) how will this be funded.

REPLY:

(1) My Department has issued a Directive dated8 April 2015 in terms of Section 41 (1) (ii) of the Water Services Act, Act 108 of 1997 appointing Magalies Water as an Implementing Agent (IA) to intervene on the upgrade of bulk water supply and sanitation systems and associated infrastructure that supply Madibeng Local Municipality (LM) ,in order to restore the operational capabilities of bulk water supply and bulk sewage disposal infrastructure. Furthermore, the Joint Operation Committee was established to manage the daily progress of this intervention.

SCOPE OF INTERVENTION

Magalies Water has prepared a Business Plan which set out the strategy to be adopted to address the challenges experienced by the Madibeng LM in the provision of water supply and sanitation services. The approach is built around the short term (immediate responses), short to medium term and long term responses. The Business Plan also includes details of the area and the water services and sanitation infrastructure together with the projected resources to be used, time frame for implementation and estimated budget requirements (Attached as **Annexure A** is Sedibeng emergency Business Plan in response to the Directive).

The Business Plan also addresses the requirements of the scope of work leading to specific action plans which covers the following:

- Response to emergency challenges (Hot-spots);
- Operation and maintenance of water and waste water plants (including pump stations);
- Bulk infrastructure refurbishment;
- Bulk infrastructure upgrades (Water and Wastewater);
- Operation and maintenance of rural infrastructure;
- Refurbishment of boreholes and drilling of additional boreholes where necessary;
- Water tanker services in emergency situations;
- Water and waste water quality monitoring;
- Optimization of the Brits water treatment plant as well as the Waste Water Treatment Works (WWTW);
- Development and implementation of a risk plan.
- Magalies Water leases bulk water services assets while my Department is working with Madibeng LM to determine future ownership
