### MINISTER OF HUMAN SETTLEMENTS, WATER AND SANITATION

The Department of Water and Sanitation (DWS) is intervening as follows to recover the monies owed by the Municipalities:

- a) There are continuous stakeholder engagement meetings arranged with the various Municipalities to resolve queries, agree on outstanding balances and payment agreements.
- b) The Department also participates in the Inter Ministerial Task Team (IMTT) on Constitutional matters relating to electricity reticulation, distribution, supply and monies owed (Now referred to as the IMTT on Service Delivery at District Level) to Water Trading Entity (WTE) and Water Boards. The IMTT have made the following recommendations:
  - Installation of prepaid/smart meters for Electricity and Water;
  - The appointment of independent revenue collectors for municipalities to collect their debt;
  - A Government wide campaign to encourage a culture of payment for municipal services:
  - Strict management of payment default with firm actions by government before the court process come to effect;
  - Supporting the municipalities to ensure the sustainability of services and finances by improving the quality of human capital in municipalities, improving financial management and improving efficiencies in the collection of revenues.; and
  - The restructuring of debts.

The total Water debt has increased by R1, 7 billion from March 2018 to Sep 2018 and a further R1,8 billion from Sep 2018 to Sep 2019.

- c) The department also participates in the Provincial Joint Tactical Committee which is comprised of the Financial Heads at the DWS Regional offices. This assists in ensuring that revenue functions are prioritised at the regional offices and enforces accountability for revenue collection. Provincial Joint Tactical Committee assists in ensuring that we can engage more customers in relation to outstanding debt and resolving queries as each finance head is responsible for the customers within their respective regions. It also assists in ensuring that the Department is more accessible to customers at local areas so that queries can be resolved speedily.
- d) The DWS is currently in the process of exploring legal measures to facilitate the topslicing of Municipal Grants. This would entail diverting a percentage (3% to 5%) of all Municipal grants of Municipalities with arrear debt and diverting this money to DWS to reduce the outstanding debt for water. For the top-slicing to be implemented, Parliament would have to approve the top-slicing of the all municipal grants.
- e) Section 59(3)(b) of the National Water Act allows the Department to restrict or suspend the flow of water to defaulting municipalities until the outstanding debt together with interests, have been paid. The Department has also resolved to take legal action against Municipalities with debt as per PFMA Section 51(1)(b)(i) which states that accounting authorities should take effective and appropriate steps to collect all revenue due. Attached is a list (Annexure A) of all the Municipalities that have been handed over and progress relating to litigation processes.
- f) In total Legal action has been taken against 65 delinquent Municipalities. Judgements have been obtained against the following Municipalities thus far:
  - 1. Emfuleni Local Municipality
  - 2. Letsemeng Local Municipalities
  - 3. Madibeng Local Municipality
  - 4. Mangaung Metropolitan Municipality
  - 5. Nketoana Local Municipality
  - 6. Nkomazi Local Municipality
  - 7. O R Tambo Municipality
  - 8. Phumelela Local Municipality
  - 9. Siyathemba Local Municipality

The fundamental challenge Honourable Members is that 60% of South African households do not pay for water services. In the majority of these cases, household incomes are so low that they would qualify for free basic water as indigents. However, since their consumption is not metered, it is possible that they are using more than the free basic allowance and should be paying for that 'excess' consumption. To address this will require a thorough review of household affordability, indigent registration procedures and financial provision for basic water supply. In addition, a process to insist on payment for consumption over and above the free basic allowance will have to be initiated.
