Whether his department is planning to close down Sedibeng Water; if not, what is the position in this regard; if so, (a) which municipalities were consulted in this regard, (b) what will happen to the debt that is owed to the said water board by the municipalities and (c) how much is owed by each municipality?

MINISTER OF WATER AND SANITATION

The Department embarked on an Institutional Reform and Realignment (IRR) process which includes the review of water boards, starting with disestablishment of the Sedibeng Water Board. The review of Water Boards is based on the following considerations, amongst others:

- Financial sustainability,
- Servicing areas that are not currently being serviced
- Addressing institutional confusion caused by the geographic footprint of several Water Boards which results in multiple water boards serving the same areas

Consultations on the disestablishment of Sedibeng Water were undertaken with all stakeholders, including three Provincial Governments, namely North West, Free State and Northern Cape.

 - Ngaka Modiri District Municipality
- (b) The assets and liabilities of Sedibeng Water will be transferred to the receiving entities, namely Magalies and Bloem Water Boards.
- (c) The debt owed by municipalities to the Sedibeng Water Board by municipalities as at 31 January 2022 is indicated in the table below:
