## MINISTER OF WATER AND SANITATION

The Department of Water and Sanitation (DWS) is overseeing the Olifantspoort and Ebenezer Upgrade Projects which are being implemented by the Lepelle Northern Water (LNW). The projects are part of the Ministerial Projects which are prioritised as Strategic Water Interventions for the Polokwane Municipality. The project scope involves the refurbishing and upgrading of the bulk water supply infrastructure of the Ebenezer and the Olifantspoort WSS to reduce water services backlogs and meet the current and projected water needs of the areas supplied by these two schemes.

The project will be implemented in three (3) phases, with phase 1 being the upgrade and refurbishment of both Olifantspoort Water Supply Scheme and Ebenezer Water Supply Scheme to address the current shortage of water. The proposed phase 1 upgrade works could increase the production of water by 40 MI/day as follows:

- Olifantspoort WSS: 30 MI/day at an estimated cost of R4 billion.
- Ebenezer WSS: 10 MI/day at an estimated cost of R500 million.

The department convenes regular meetings with LNW where progress or lack thereof is interrogated, and solutions agreed upon to expedite the project.
