Whether his department has incurred any (a) irregular and/or (b) fruitless and wasteful expenditure since 1 January 2023 up to the latest specified date for which information is available; if so, what are the relevant details?

MINISTER OF WATER AND SANITATION

(a) The Department incurred irregular expenditure on the Water Trading Entity Account.

The Department's Water Trading Entity has incurred irregular expenditure due to awarding of a three-year term contract in relation to which service providers were appointed for mechanical and major plant and machinery installation, maintenance, repairs and upgrade refurbishment. The department incurred irregular expenditure due to inconsistencies in the evaluation processes.

Irregularities identified were, amongst others, awarding of contracts to bidders who did not score the highest points in the evaluation process. The approved specification and evaluation criteria were not followed by the Bid Evaluation Committee. This resulted in the irregular appointments as indicated below:
