Ermelo WWTW	 Directive issued on 05/10/2017 Criminal Case opened with SAPS in November 2019. The Prosecutor initially did not want to prosecute. After engaging the Prosecutor, the case was reopened, and evidence is being gathered. The Investigation team is meeting on 14 July 2023. The Department is also embarking on the civil matter against the Municipality. The court date is scheduled for August 2023.
