Water Resource Status

WATER RESOURCE STATUS	MEANING OF CURRENT STATUS
Early Drought Caution	'Continued water wise use encouraged due to lower than anticipated dams level, cautioning possible start of a drought cycle' The main dams supplying the City are approximately 10% lower than last year - as shown on Page 3. While there is no immediate reason for concern and no expected restrictions for the next year, this updated drought risk status is part of the City's proactive approach to monitoring for and managing future droughts. This status and the corresponding actions are discussed in the Water Outlook 2022. The Water Resource Status will be updated again in December 2025.

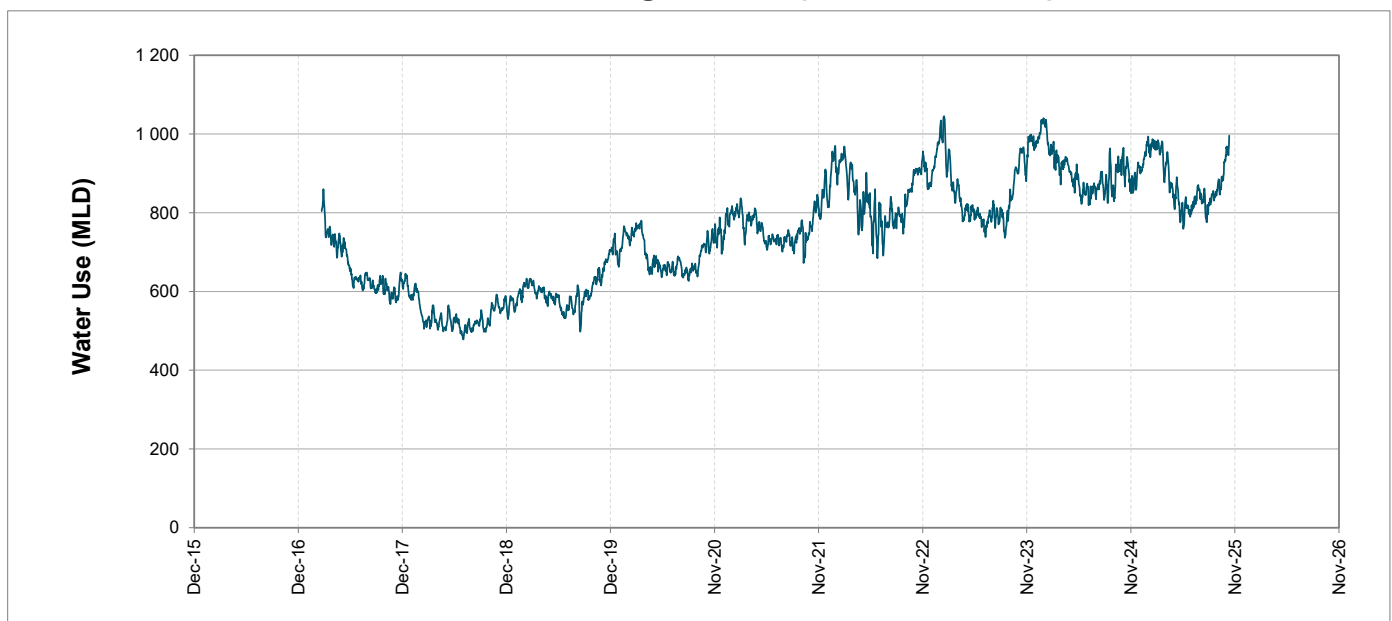

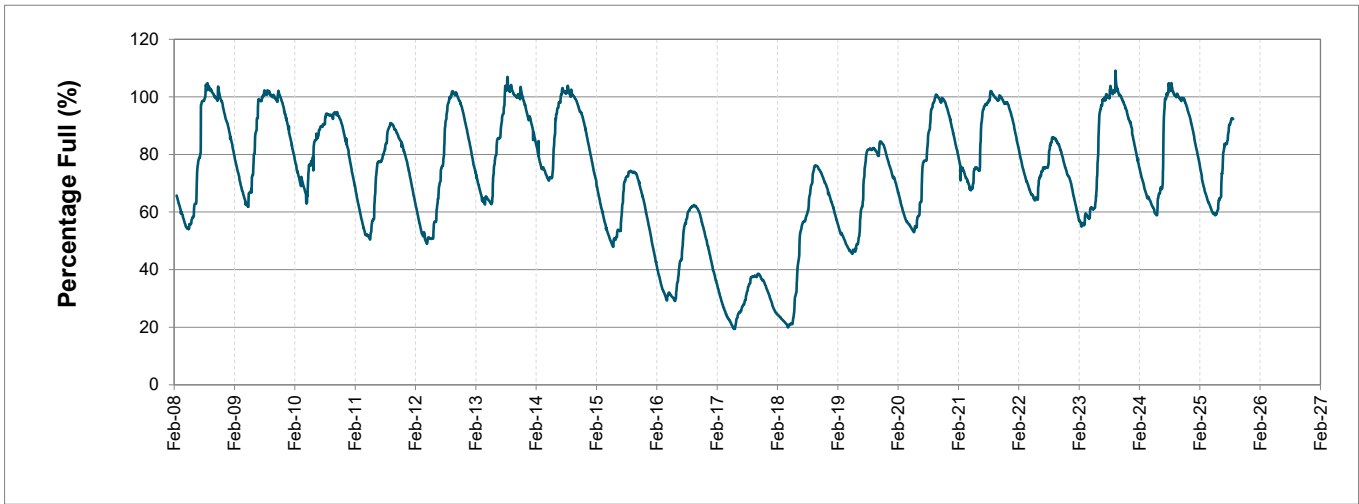

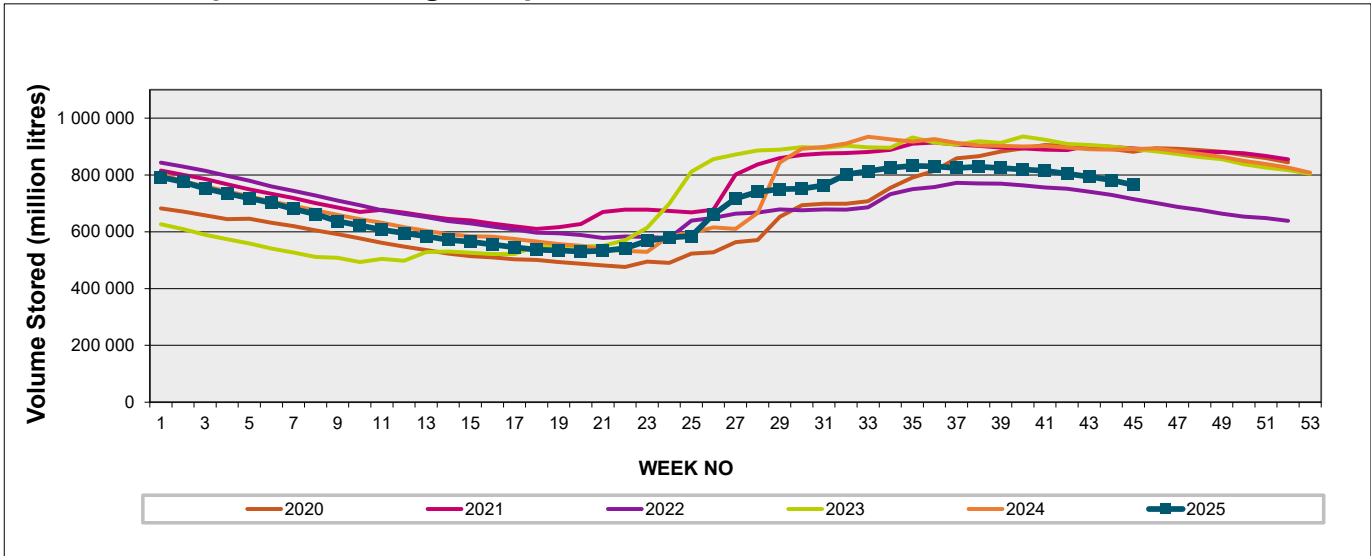

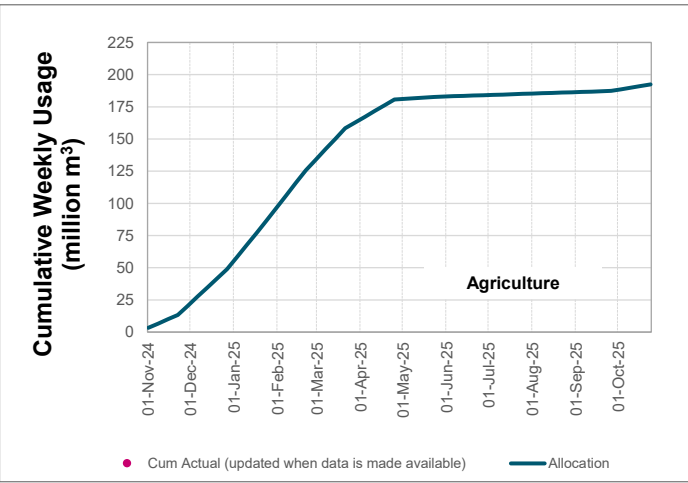
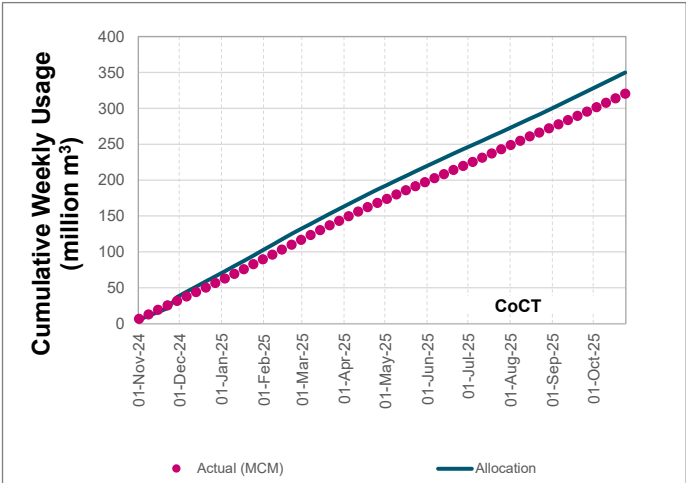
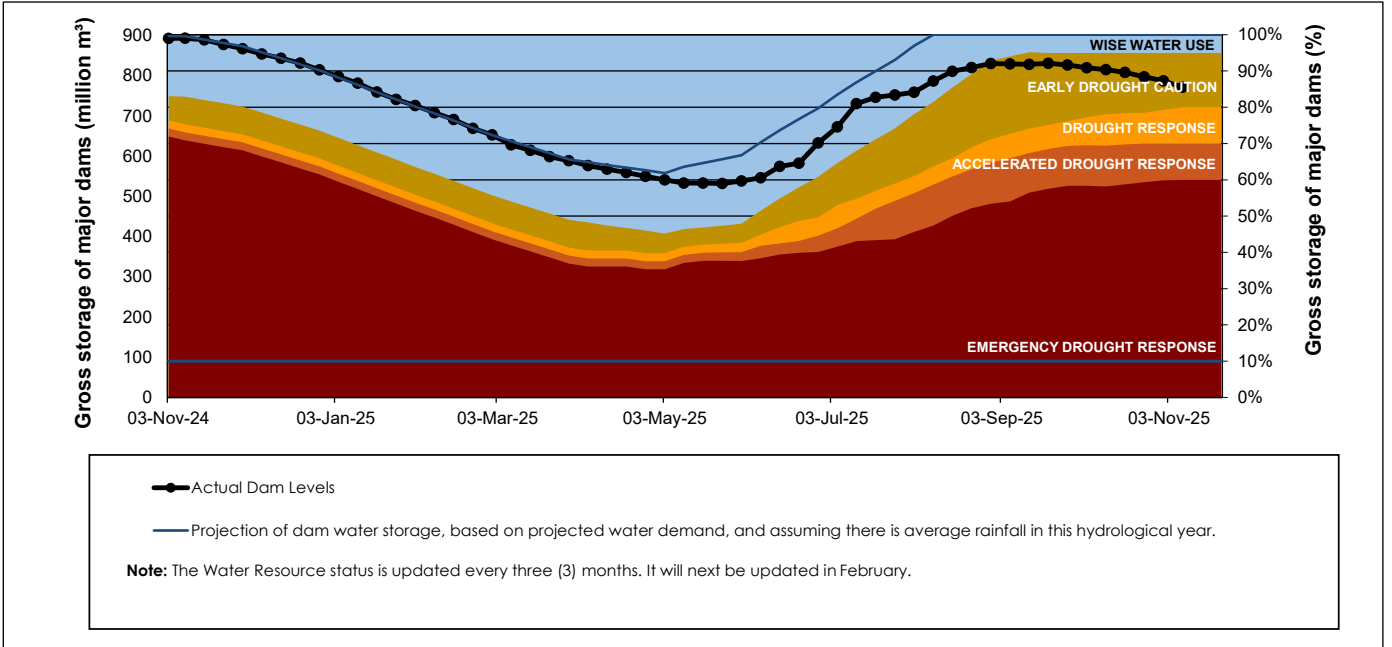
WCWSS Storage Record (2008 - Present)

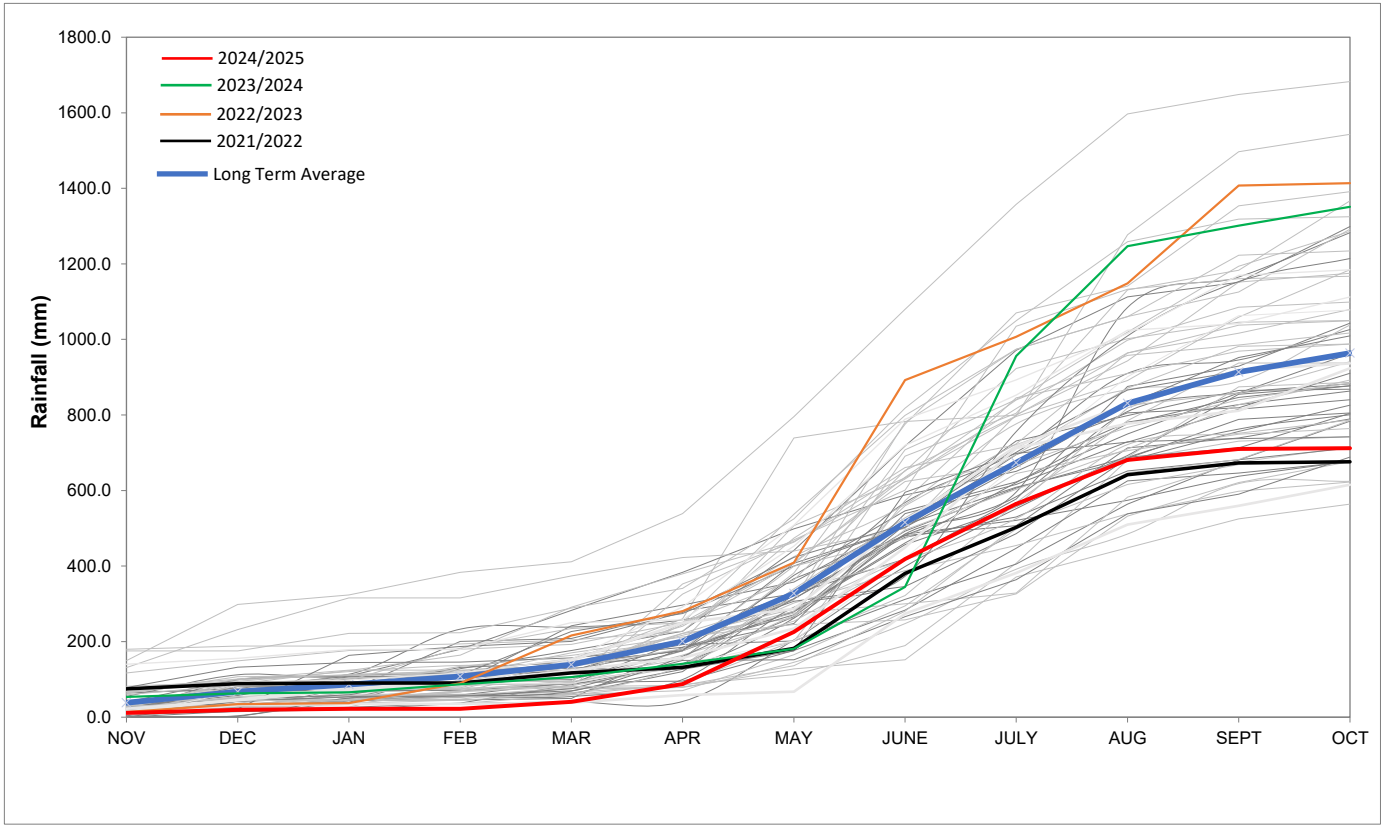

This table shows CCT drinking water quality compliance according to the South African National Standard 241:2015. Compliance, measured against all prescribed chemical and microbiological components, consistently exceeds the very high CCT target of 99%. (Overall compliance percentages of continuous sampling and analysis are released on a monthly basis.
