#### Hi Donavan

I have been wildly busy on the farm so apologies for the tardy reply.

There is a large stone weir[Foxwood Weir] across the river which will be flooded by the dam . It was built in 1901 by the Broli Bros and is quite historical . Arising from that weir is about 5km of water furrows that lead to cultivated lands. The furrow and some of the lands were extensively damaged in the last flood and I have not resurrected them knowing that Foxwood is in the pipeline. The lands must be plus minus 8H . There is fencing ,some netted ,some not and farm roads. It is difficult to estimate the extent of these. There is a water system with pipes and troughs for watering stock and a small stock water dam. There is also an old Shepard's shack and kraal which we still use. All these are on the property Leeuhoek 129.

Below the dam wall there are also lands that were irrigated by the furrow from the Foxwood Weir- I guestimate they must be 6H.

Off the top of my head that is it but I may well have forgotten stuff.[assuming you have the power lines etc. in your sights]

# **PROJECT OVERVIEW:**

The Department of Water and Sanitation (DWS) is investigating the feasibility of developing a multi-purpose dam (known as Foxwood Dam) on the Koonap River outside of Adelaide, which falls within the Nxuba Local Municipality in the Amathole District Municipality in the Eastern Cape.

The development of Foxwood Dam could provide additional assurance of domestic water supply within the region. In addition, the dam has the potential to mobilize the water resources to allow for downstream irrigation development.
