#### "REGISTRATION OF SERVITUDE.

By Notarial Deed No.284/1938 dated 30th October 1937 an agreement relative to an existing weir on the Koenap River the construction of a furrow therefrom, syphons, culverts, outlets and extensions to the furrow and the rights to water flowing therein has been entered into subject to conditions as will more fully appear on reference to the said Notarial Deed registered this day in the Servitude Register under No.284/1938."

- C. By Notarial Deed of Servitude No. K1170/1997 dated 17 September 1997, the Remainder of the Farm Leeuw Hoek No. 129 Nxuba Municipality, Division of Bedford, Eastern Cape Province, measuring 244,2415 hectares, is subject to a Praedial Servitude 14 metres wide to lead water from the weir on the Koonap River along a furrow reflected on Servitude Diagram No. 2949/1997 and No. 2948/1997 in favour of Portion 7 (a portion of portion 1) of the farm Norwood number 127, Division of Bedford in extent 80,2291 hectares, held by Deed of Transfer No.T33632/1980. Subject to certain conditions as will more fully appear from the said Notarial Deed of Servitude.
