### 1. INTRODUCTION

GA Environment (Pty) Ltd has been appointed by the DWS as independent Environmental Assessment Practitioners to undertake an Environmental Authorisation (EA) through a Scoping and Environmental Impact Assessment (EIA) and a Water Use Authorisation (WUA) through a Water Use License (WUL) process for the proposed Lower Coerney Balancing Dam in Sunday's River Valley Local Municipality, Eastern Cape Province.

The proposed Lower Coerney Balancing Dam development is located on Portion 7 of the Farm Scheepersvlakte No. 98, owned by Scheepersvlakte Farms (Pty) Ltd, Farm 713 and Farm Enon Mission 574 (Remaining Extent of Farm 40). The site has approximate site center coordinates of 33°26'29.77"S and 25°37'23.68"E. The proposed location of the Coerney Dam is upstream of the Coerney Siphon outlet in a valley east of and adjacent to the existing Scheepersvlakte Dam. The site can be accessed from a gravel road which connects to the R336 approximately 4km south west of the site. There are currently no formal roads within the Scheepers Vlakte farm. Coerney Dam's footprint is approximately 77.1 hectares. The footprint of the proposed Coerney Dam overlaps with portions of the planned future Scheepersvlakte Farms development. The area of proposed future citrus orchards impacted by the proposed dam is approximately 36 hectares.

The existing Scheepersvlakte Balancing Dam is a balancing facility for water supply to the Lower Sundays River Government Water Scheme (LSRGWS) and the Nelson Mandela Bay Metropolitan Municipality (NMBM), and for emergency supply. The need for this authorisation process for the new balancing dam is to provide additional balancing storage in addition to the existing Scheepersvlakte Balancing Dam, which has lost storage due to siltation. The main purpose of the proposed new balancing dam at the Coerney site is to eliminate the operational and balancing storage limitations imposed by Scheepersvlakte Dam.

The main advantage of the dam is that it will be operated under gravity. The dam will be filled from the Kirkwood primary canal via a new pipeline and the dam will supply the Nooitgedacht Wastewater Treatment Works (WTW) via a new connecting pipeline to the existing 1 400mm Nooitgedacht pipeline. The proposed Coerney Dam will be filled, and topped up, over a lengthy filling period through gravity supply. The existing Scheepersvlakte Dam and proposed Coerney Dam, although filled from the same source, should be operated separately under normal operations. The proposed Coerney Dam will be used as balancing storage for NMBM (and the landowner), and the Scheepersvlakte Dam will revert to its original function and will only be used as balancing storage for irrigation.

The development of Coerney Dam and associated infrastructure will result in the clearance of indigenous vegetation and infilling or depositing of material from a watercourse.

According to the EIA Regulations 2014, as amended, a Scoping and EIA Process is required for the project based on the following triggered activities: **GNR 983 Listing Notice 1** (Activities 9, 12 add and **GNR 984 Listing Notice 2** (Activities 15 and 16) and **Listing Notice 3.** These activities pertain to the footer well as a many associated infrastructure, infilling or deposition of material from a watercourse and the clearance of indigenous vegetation of more than 20 hectares respectively. A

Water Use Authorization (WUA) will be triggered in terms of Section 21 of the National Water Act (NWA), 1998 (Act No. 36 of 1998). The triggered Section 21 activities are; (b) storing of water, (c) impeding or diverting the flow in a watercourse, (d) engaging in a streamflow reduction activity, and (i) altering the bed, banks, course or characteristics of a watercourse.

On the 5<sup>th</sup> of June and the 9<sup>th</sup> of September 2020, the Minister issued directions regarding the measures to address, prevent and combat the spread of the COVID-19 relating to the National Environmental Management Permits and Licences. One of the requirements provided in the directions is that a Public Participation Plan (PP Plan) shall be submitted to the Department of Forestry, Fisheries and the Environment (DFFE), in instances where a case officer has been assigned to the project then the Public Participation Plan shall be submitted to the case officer.

According to Section (2)(4)(f) of the National Environmental Management Act, the participation of all Interested and Affected parties (I&APs) must be promoted and all potential I&AP's must be informed early and in an informative and proactive way regarding applications that may affect their lives or livelihood. In order to give effect to the above sections, it is essential to ensure that there is adequate and appropriate opportunity for Public Participation (PP) in decisions that may affect the environment.

The purpose of this document is to provide the competent authority with direction on the public participation processes to be fulfilled while ensuring that the Environmental Assessment Practitioner's actions limit the threat posed by the Covid-19 pandemic and to alleviate, contain and minimise the effects of the national state of disaster. It is the intention of GA Environment to ensure that reasonable opportunity is provided for public participation and that all administrative actions are reasonable. While the challenges posed by COVID-19 pandemic are drastic, the specific measures recommended have been carefully considered to ensure that the process is clear and participatory to all I&APs.

The NEMA EIA Regulations 2014 (as amended) prescribe the minimum requirements for public participation as summarised in **Table 1**. Due to the COVID-19 pandemic and in line with the Section 27(2) of the Disaster Management Act, additional measures have been proposed in this PP Plan. The level of public participation required for the proposed Lower Coerney Balancing Dam has been informed by:

- the scale of anticipated impacts of the proposed project;
- the sensitivity of the affected environment and the community interest in the matters related to the project; and
- the characteristics of the potentially affected parties.

# 2. LEGISLATIVE REQUIREMENTS

Chapter 6 of the NEMA EIA Regulations 2014, as amended (Government Notice R. 982 in Government Gazette No. 40772 of 07 April 2017) prescribes the minimum requirements for Public Participation through which all role players including potential I&APs, state departments, organs of state, and the competent authority (CA) to obtain clear, accurate and understandable information about the environmental impacts of the proposed activity or implications of a decision. These requirements and the sections of the report in which they have been addressed is provided in **Table 1.**
