





South Africa's Integrated Strategic Management of Rhinoceros is starting to bear fruit, with a recent report showing that the country has turned the tide on rhino poaching.

Acting Minister in The Presidency for Planning, Monitoring and Evaluation, Nosivwe Mapisa-Makula, said Cabinet has welcomed the feedback on the Integrated Strategic Management of Rhinoceroes, which Environmental Affairs Minister Edna Molewa tabled on Sunday 8 May.

Since the beginning of this year alone, 206 alleged poachers have been arrested.

Between April 2015 and March 2016, there were 49 finalised cases involving 103 accused. Eighty of the accused were convicted, resulting in a conviction rate of 78%.

Atterbury vestig nuwe groeifonds

Die eiendomsontwikkelaar en -belegger Atterbury Group het 'n nuwe eiendomsgroeifonds gevestig as beleggingsvoertuig vir hestaande en toekomstige bates in Suid-Afrika, Namibië en Mauritius.

Die Atterbury Property Fund begin as 'n geslote ongenoteerde fonds met aanvanklike bates van R3,1 miljard. Atterbury Property Holdings, waarin Rand Merchant Bank Holdings besig is om 'n 25,01%-belang te koop, gaan 80% van die aandele in die groeifonds hou en Atterbury se personeel die oorblywende 20%.
