Dear Donovan

Thank you. You seem to have sent me the BID Phase 1 documents two more times, even though they are called something else...!?

In any event, Isaiah had already sent me the Phase 1 & 2 docs – thanks. I would be interested to see the Debottlenecking one as well if you could send that to me.

Our interest is not specific, as the pipeline routes will not impact either our gas or coal rights, which are north and west of Lephalale respectively. Also, our developments will not impact water use over and above what has been projected: we depend on Eskom or Sasol or some other downstream development in order for us to develop our resources and the latter have already provided their total usage requirements to the process. However, we do need to know that the project of providing water is indeed happening and the time frame: hence that water will be available in good time for our developments. Our gas project would be a net producer of water.
