BRIEF PROGRESS REPORT BY STUDY LEADER

1. Outline of work done so far

- 1.1 Work commenced in December 2009. Many team members however had leave during December, resulting in not much progress being made.
- 1.2 The first Team Meeting was held on 9 December 2009. This was an important kick-of meeting and the following aspects were inter alia discussed:
 - The refinement of the Gantt chart in the proposal,

 - A contract,

- Aurecon has already received invoices from it's sub-consultants but cannot submit the invoices before 3.2 the main contract is in place and signed.
