These investigations needed to take into consideration the inputs and concerns of the KwaBhidla Traditional Council.	-	-

1.	Welcome & Purpose of Meeting		
1.1	The meeting commenced at approximately 11H00 on site. Discussions were held in IsiZulu. D. Henning explained that the aim of the meeting was to present the findings of the engineering investigations for the realignment of the R617 road, as a result of the proposed Smithfield Dam.	-	-
2.	Discussions		
2.1	An unnamed attendee mentioned that a survey was conducted around 2014 for Smithfield Dam, and that the community was informed during this survey that they should not develop their dwellings further due to the proposed dam. D. Henning stated that the community should continue with the use of the land, as the Relocation Action Plan will take into account what needs to be moved at the designated time. K. Bester cautioned against people building new dwellings in the project footprint in the hope of receiving a new home at the time of resettlement.	-	-
2.2	An unnamed attendee asked what will happen in the case of graves being affected by the project. D. Henning explained that the relocation of the graves will need to abide by the legal requirements, in consultation with the affected family.	-	-
2.3	An unnamed attendee stated that they currently have areas for grazing and asked if this will be considered when they are relocated. D. Henning indicated that the resettlement process needed to consider the reinstatement of livelihoods.	-	-




	K. Bester stated that the project is not yet approved and that various steps still needed to be taken prior to construction. He indicated that the soonest that construction may start is in 2021. He stated that relocations will be done as part of the project and that people will be engaged with further during the next phase (final design).		
2.5	An unnamed attendee asked if they will be provided with water and electricity as part of the relocation. K. Bester stated that it depends on what they currently have, and that people who need to be relocated must not be worse off than before the project was implemented.	-	-
2.6	M. Zondi asked that preference be given to the local community for employment opportunities associated with the project. K. Bester stated that certain standards would be prescribed by the Implementing Agent to the contractor in terms of local employment and skills development.	-	-
2.7	An unnamed attendee enquired about the safe distance to the R617 for dwellings. K. Bester explained the requirements of the road and that the route will be optimised during the design phase. He stated that this would also take into consideration existing dwellings. He noted that only affected dwellings would be relocated. K. Bester indicated that the hall will need to be relocated, as it will not be safe for children to cross between the hall and the school.	-	-
2.8	K. Bester asked the community what route they prefer the most. They indicated route 1 A or B (routes on the right embankment), as they are the closest to the community.		
2.9	M. Zondi emphasised the need to keep momentum with community engagement. D. Henning mentioned that a dedicated person would be appointed in the future by the implementing agent to engage with the community.	-	-








