## uMkhomazi Water Project Phase 1

## **Invitation to a Senior Officials Meeting and Site Visit**

Phase 1 of the uMkhomazi Water Project (uMWP) is currently being undertaken conjunctively by the Department of Water Affairs (DWA) and Umgeni Water. It involves a feasibility study for the transfer of water from the undeveloped uMkhomazi River to the existing Mgeni system to further augment water supply to the Durban, Pietermaritzburg and surrounding areas. The uMWP comprises the following infrastructure:

- A new dam on the uMkhomazi River at Smithfield near Richmond.
- Water conveyance infrastructure, viz. a tunnel(s) to Langa Balancing Dam.
- A water treatment works in the uMlaza River valley.
- A gravity pipeline to the Umgeni Water bulk distribution reservoir system, below the reservoir at Umlaas Road.
