REQUIREMENTS: The candidate must be in possession of an appropriate trade test [ Diesel Mechanic, Earthmoving Mechanic, Fitting/Turning, Millwright or Electrical trade] certificate issued by an accredited institution plus 8 years post qualification experience (within field of qualification) as an artisan with, at least, 3 years managerial experience. The candidate must be in possession of a valid Code 8(B) driver's license. The candidate must be in possession of at least a Matric Certificate or N3 Certificate. A N6, National Diploma, OR BTech in Mechanical, Electrical Engineering would be advantageous. The candidate must be computer literate in Microsoft software. The following experience and exposure will be mandatory a) basic knowledge in the field of fabrication, welding and corrosion protection, b) experience and knowledge of fleet management, licensing and C.O.F. c) transporting of plant and transporting permits, d) load testing of cranes and lifting equipment e) pneumatics and hydraulics coupled with auto electrical repairs. The candidate must have proven problem-solving skills and excellent human relations and administrative skills coupled with good communication and interpersonal skills. The candidate must have knowledge of Public Finance Management Act (PFMA), Treasury Regulations, Government procurement procedures and other legislation prescripts.
