Applications must be submitted using the newly implemented Z83 form obtainable on the Department of Water and Sanitation website, under career opportunities or the DPSA website, under vacancies in the Public Service (point 4) and should be accompanied by a comprehensive CV (with full particulars of the applicants' training, qualifications, competencies, knowledge & experience). All required information on the Z83 application form must be provided. Other related documentation such as copies of qualifications, identity document, etc need not to accompany the application when applying for a post as such documentation must only be produced by shortlisted candidates during the interview date in line with DPSA circular 19 of 2022. With reference to applicants bearing professional or occupational registration, fields provided in Part B of the Z83 must be completed as these fields are regarded as compulsory and such details must also be included in the applicants CV. Failure to complete or disclose all required information will automatically disqualify the applicant. No late, applications will be accepted. A SAQA evaluation certificate must accompany foreign qualification/s (only when shortlisted). Applications that do not comply with the above-mentioned requirements will not be considered. REQUIREMENTS: B.Tech Civil Engineering, a valid Professional registration with ECSA as Pr Engineering Technologist or a valid Professional registration with SACPCMP as Pr Construction Manager or equivalent. Registration as a Candidate will not be considered. Minimum of 10 years' experience in managing construction of water related infrastructure projects such as: dams, bulk water pipelines, open channels, post first engineering qualification. Minimum of 4 years' experience in leading/overseeing multidisciplinary team/s. Experience in managing internal and external stakeholders. Disclosure of a valid driver's licence is a must. Knowledge of built environment legislative requirements. Experience in planning, scheduling, resource planning, and construction management of water resources infrastructure projects. Extensive experience in project and construction management of large water infrastructure projects. Understanding of the complete project life cycle from initial planning stages through to completion. Extensive contract management and negotiation skills experience. A detailed understanding of construction procurement processes. Experience in financial planning and financial management. Knowledge of project risk analysis and risk management. Experience in integration management, ability to relate with associated professional disciplines in a multi-disciplinary project team. High-level communication skills (verbal and written). Conflict management and management of team dynamics. Problem-solving and analysis skills. Computer proficiency (such as MS Office, MS Projects, CCS Candy amongst others). Must be able to work independently, be self-motivated, responsible and reliable.

DUTIES: The incumbent will be required to manage and oversee all aspects of the construction of Ntabelanga dam project, as the main contractor. Monitor and manage project performance according to organizational goals to direct or redirect project deliverables for the attainment of organizational objectives.
