## **1. INTRODUCTION AND BACKGROUND**

It is a legal requirement to ensure public and stakeholder participation during the process of water resource classification. The Olifants Doorn WMA is the first area in which water resources are being classified in South Africa. The Department of Water Affairs (DWA) appointed Blue Science Consulting cc to undertake the technical study to determine the classes for the water resources in the Olifants Doorn WMA. Nosipho Consultancy cc was appointed as subcontractors to guide, facilitate and undertake the public and stakeholder participation process.

## **2. MOBILISATION OF STAKEHOLDERS**

### **2.1 National awareness**

The Department of Water Affairs has placed advertisements in National newspapers to inform members of the public and water stakeholders of the start of the classification of water resources in South Africa. These advertisements appeared in the following National newspapers:

- Sunday Times, and
- Mail and Guardian

### **2.2 Regional awareness**

Three newspapers which are distributed in the Olifants Doorn Water Management study area were selected and notices in Afrikaans, English and isiXhosa were published in the newspapers listed in table 1. It included the following:

- Olifants Gazette,
- Ons Kontrei, and
- Noordwester.

The notices announced the first public meeting, the purpose thereof and the stakeholders was requested to indicate their interest by registering on the database. Appendix A provides copies of the advertisements.

### **2.3 Stakeholder database**

Various existing databases (Water User Associations, CMA reference group) was consulted in the in the area to ensure inclusivity of all sectors, stakeholders and affected parties. The database that was used consisted of more than 350 stakeholder members and was used to notify and invite people to participate and a record of participation during the process was kept. The database was updated continuously during the study period and after each of the public meetings. The final database consist of various sectors which include the following: Local Government, National and Provincial Government Departments, Water User Associations, Nature Conservation and Environment, Water Catchment Forums, Community organisations, Emerging Farmer (individuals and forums), Commercial Farmers (individual and farmer unions), Labour Unions, Private Consultants and individuals, Universities, Olifants River Estuary,

Management Forum, Verlorenvlei Estuary Management Forum, Tourism and Recreation and Department of Water Affairs (National and Provincial).

## 2.4 Public Participation Meetings

### 2.4.1 Communication and invitations to the meetings

With the inception of the study a classification background document and brochures were developed for the water stakeholders and made available in the three official languages of the Western Cape Province: English, Afrikaans and isiXhosa. Various mediums was utilised to communicate with the stakeholders: e-mails, fax, telephone in preparation of each Public Participation meeting and also during the study period. Stakeholders could also access documents from the website: [www.ewisa.co.za](http://www.ewisa.co.za) and the website of the Department of Water Affairs [www.dwa.gov.za](http://www.dwa.gov.za). The classification guideline documents, according to which classification is to be conducted, was also made available to stakeholders.

All three public meetings were held in Clanwilliam at the Rolbal Klub. At each of the meetings comment sheets were made available for the stakeholders that wanted to provide their comments and concerns in written form. Minutes were kept of each of the public meeting. A comments and responses register was also compiled and updated

after each public meeting which resulted in a consolidated comment and responses register which was distributed at the second and third public participation meetings to allow stakeholders to scrutinize.

#### **2.4.2 Language Accessibility**

All the public meetings were conducted in both Afrikaans and English and as with most of the documents, stakeholders were also encouraged and invited to speak in their mother tongue during the Public Participation meetings, as there was translation services available.

#### **2.4.3 Nature of Public Participation Meetings**

The first and second public meetings were done in a workshop format to allow maximum participation by the stakeholders. Presentations were also done in two languages simultaneously (two screens) for the benefit of the stakeholders. The agenda of each meeting was also set in such manner to allow maximum time for questions, clarity and to raise any other concerns.

Table 2 provides a summary of the specific topics that were covered in each of the three public meetings.

More than 150 comments and questions to which responses were supplied are captured in the register.

For each of the Public Participation meetings a set of minutes, agenda and invitations and a sheet of comments and concerns are available. All these documents were distributed at least 14 days prior to each Public Participation meeting.

#### 2.4.4 Technical meetings with WUA

In addition to the three formal public and stakeholder consultation meetings the study team members also engaged during four meetings with representatives of the following Water User Association:

- Koue Bokkeveld,
- Citrusdal,
- LORWUA, and
- Sandveld

The purpose of these meetings was to obtain input into the agricultural economic modeling in order to determine the impact of either an increase or decrease in the availability of water on agricultural activities.

#### 2.5 Challenges experience during the stakeholder participation process

- The Olifants/ Doorn Water Management area is very vast and stakeholders have to travel a radius of 400 kilometers to attend the public participation meetings in Clanwilliam. A budget was used to cover the travel costs of stakeholders groups that needed to travel long distances to attend the public meetings.
- Stakeholder fatigue, anger and frustrations: it was very evident during the stakeholder processes that there are many unresolved issues in the Olifants Doorn Water Management Area, and stakeholders then use this opportunity to express their concerns related to the unresolved issues such as the raising of the Clanwilliam Dam, Non existence of Catchment Management Agency and lack of support to Emerging Farmers.
